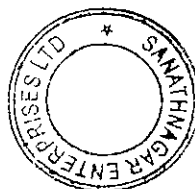

Note : The Rehabilitation Scheme sanctioned by BIFR vide order dated 22.08.2005 (case No. 356/2001) provides to write off the existing Equity Capital Subscribed by 90%. Beside also directs for demerger of Bakelite Hylam Limited. Accordingly, Bakelite Hylam Limited have to issue 3 equity shares for every 10 shares held by their shareholders besides 2 equity shares of the newly formed resulting companies i.e. Bakelite Resins & Foams Limited and 5 equity shares of Panel Boards & Laminates Limited.

Since the Auto Corporate action for reduction of Original capital of Bakelite Hylam by 90% having not been approved by CDSL, the matter is kept in abeyance. The entire process shall be completed only on reduction of shares capital by CDSL and dismantling the existing ISIN No. and allotment of new ISIN No. in lieu thereof. Besides allotment of ISIN Numbers for newly formed companies on submission of requisite documents to the Depository.

The shareholding pattern therefore is arranged considering the provisions and direction under BIFR order and allotment of equity shares of newly formed companies to the shareholders of Bakelite Hylam Limited as per the ratio hereinabove.

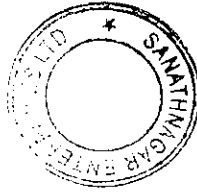
